### Special Discount

County school districts paying one lump sum to enroll ALL eligible schools in their district qualify for a 15% discount. If a school district elects to take the 15% discount, payment must be paid by one (1) check.

Non-public schools within one county or defined organizational structure (diocese, parish, etc.) containing several schools eligible for enrollment can qualify for 15% discount. If a group of non-public schools within a county or defined organizational structure desire to receive the 15% discount, payment must be made for all eligible schools by one (1) check.

### Late Enrollments

No enrollments will be accepted after a September 15 postmark, unless the principal can demonstrate extenuating circumstances. All payments must be completed by September 15.

### Purchase Orders

FSMA will accept purchase orders and invoice the district business office directly. **Purchase orders should be received by FSMA no later than August 1<sup>st</sup>** to allow processing time by both FSMA and the district's business office.

Submission of a **purchase order is not** considered payment. Payment by check must be postmarked no later than **September 15**.

**Note 1:** For combination schools (K-12, K-8, 6-12, etc.) count the number of students from 6<sup>th</sup> grade up to determine dues. Combination schools pay only one fee.

**Note 2:** If two schools reside on one campus (e.g. middle school and high school) and share the same music director, then pay combination dues. If each school on the campus has a separate music program with separate music directors, then each school must pay separately to be members.
